Hi Ben,

I believe you are able to have items added to the Village Board meeting agenda. I have two items that need board approval at the June board meeting. The items are approval to purchase Axon unlimited 3rd party storage for \$53,486 for a 40 month contract. The first year payment is \$9,900. This payment was approved as part of the Axon CIP approved by the village board as part of the FY 2024 CIP budget. The second approval is for the purchase of Axon Fleet 3 license plate readers for the squad Fleet 3 cameras. The cost is \$71,095 for a 40 month contract. The first year cost is \$20,000. This amount is part of the Axon CIP approved by the Niles Village Board as part of the FY 2024 budget.
